

COVID-19 AND US DEPARTMENT OF VETERANS AFFAIRS

 Veterans and their Families, Caregivers and Survivors have many VA resources available to answer their questions on services related to the Coronavirus, or COVID-19 available from the Department of Veterans Affairs.





Basic Eligibility for VA Healthcare Benefits

Veterans status is established by

- Active duty service in the United States Military (Army, Navy, Air Force, Marines, or Coast Guard).
- 2 year minimum of active duty service, discharged under Honorable or General Discharge and Other Than Honorable due to certain medical circumstances.



Veterans Health Administration Co-Pays

- Many veterans qualify for COST-FREE health care and/or medication based on:
 - Service connected disability rating 50% or greater
 - Receipt of a Purple Heart
 - Former POW
 - Income below VA threshold
 - Other qualifying factors
- Outpatient Copays: \$15
- Specialty Care Service: \$50
- Medication: \$5....\$8....\$11 (30-day supply generic and brand name medications)





CHAMPVA HEALTH INSURANCE

- VA healthcare coverage for dependents of Veterans service-connected rated 100% permanent and totally disabled.
- Survivors of Veterans who died from VA-rated SC conditions or who, at the time of death, were rated permanently disabled.
- Survivors of persons who died in the line of duty, and not eligible for DOD/TRICARE benefits.

Tricare and VA Healthcare

Tricare recipients are eligible to use VA healthcare for Emergent Care which includes Veterans, Retirees, Spouses and eligible Dependent Children.

COVID-19 and Financial Hardship

- VA Medical Care Hardship program may help you qualify for VA Health Care enrollment. If your income has recently changed, you may qualify for enrollment even if it was denied.
 - Personal circumstances such as loss of employment, sudden decrease in income, or increases in out-of-pocket family health care expenses, factor into VA's hardship determination.



COVID-19 AND US DEPARTMENT OF VETERANS AFFAIRS

- Veterans who are experiencing medical concerns are asked to call the VA Nurses Helpline.
- •The VA Nurses Helpline is staffed with live clinicians <u>24 hours a day 7 days</u> a week to answer health related questions.

COVID-19 and Women Veterans

- Basic medical assistance is available for Women Veterans at all VA facilities.
- VA facilities are not equipped to care for critically ill pregnant Women Veterans.
- Pregnant Veterans with mild symptoms can be tested at VA facilities.
- Pregnant Women Veterans w/severe symptoms can be tested at VA Emergency Departments w/ OB-GYN capacity. ED will notify Veterans Maternity Provider.




VA COVID-19 TESTING

VA FOREIGN MEDICAL PROGRAM

- VA Foreign Medical Program(FMP) is a VA healthcare program for Veterans with service-connected conditions living or traveling abroad.
- VA assumes payments for certain necessary health care services associated with the treatment of Veterans service-connected conditions, or disabilities aggravating a service-connection and care for Veterans in Vocational Rehabilitation(VR&E) Chapter 31.

 VA has introduced the use of technology to enable Veterans, Families, and Caregivers the chance interact with their doctors, pharmacists, and providers.







VA Video Connect

• VA Video Connect allows Veterans to conduct live video visits with their doctor by using the camera and microphone on your video equipment.









Requirements for Veteran's to receive VA Video Connect to Home

- Private space
- Veteran consent to telehealth (documented in chart)
- Veteran has either a Smart Phone-Laptop-Desktop-Tablet
- Veteran has internet access (Wi-Fi or 4G)
- Veteran has E-Mail account
- A test call should be completed prior to initial VVC appointment
 Veteran calls National Telehealth Technology Help Desk
 (866) 651-3180 or (703) 234-4483 Mon-Sat 7am-11pm
 Designee conducts test call

*Note: VA issued Tablets can be requested for those patients with no access to care without them. Talk with your Facility Telehealth Coordinator.
